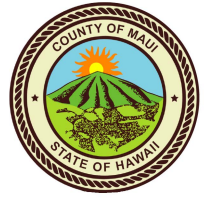

**QUALIFIED FIREARMS INSTRUCTOR
CHECKLIST OF MINIMUM REQUIREMENTS**



Qualified Firearm Instructor Applicants Must Meet All Requirements Below To Be Eligible for Certification by The Chief of Police

1. Certified to teach one of the following firearm safety course(s):

NRA-certified in:

"NRA Basics of Person Protection Outside The Home Course"

"NRA Basic CCW"

An equivalent course

Certified by another organization.

Certified by a government organization (military or State)

Certified to teach the NRA Basic Pistol Course or equivalent

2. Qualified to teach the Hawaii Firearms Law because (must satisfy one):

The instructor will have an attorney present to advise on HRS §134.

The instructor has certified that he/she is sufficiently familiar with HRS §134 and other applicable laws. (*certification is completed on instructor application pg. 2*)

3. Legal requirements. Must satisfy all three of the requirements below.

The instructor has not been convicted of any crime, or found liable in any civil matter, involving dishonestly or fraud.

The instructor has not had a concealed carry license revoked

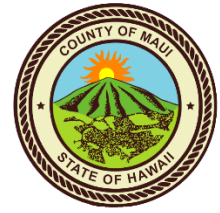
The instructor is lawfully permitted to possess firearms

4. The instructor has attached a copy of the course curriculum for the written test and the parameters of the handgun safety or proficiency test to be used, provided that the live fire proficiency course for CCWs is equivalent to or more difficult than the NRA's Basic CCW or comparable course, and the written test covers the required topics including, firearm safety, proper use of firearms, firearm restrictions related to domestic violence, firearm use in low-light situations, firearm retention, risks of carrying firearms in public, safe carrying and storage of concealed and unconcealed firearms, and chapters 134, 663-9.5, and 703, HRS.

- ▶ That I will administer MPD's prescribed Course of Fire for the live fire portion of the course, (see #1 on Instructor Checklist) and
 - ▶ that applicants not obtaining a qualification score of 70% or more will not be considered to have passed the course, regardless of their score on the written portion of test.

I certify, under penalty of perjury, that: (choose option 1 or 2)

I have current and detailed knowledge of Hawaii law on self defense and use of force, including chapters 134, 663-9.5, and 703, HRS.

I will rely on an attorney licensed in Hawaii to present on these topics.

I certify, under penalty of perjury, that I have not previously been convicted of any criminal offense involving dishonesty or fraud, and that I have not previously been found liable in any civil court for any act involving dishonesty or fraud.

I certify, under penalty of perjury, that I am no legally prohibited from possessing or handling firearms in Hawaii or elsewhere.

I have attached a copy of the written examination to be used, and this examination satisfies MPD General Order 303.6.

I declare, under penalty of perjury, that all of the information above is truthful, and that all of the attachments are true and correct copies, or original documents demonstrating my qualifications to administer the specified firearms course as required by MPD General Order 303.6 and that no other legal restriction to me serving as an instructor exists.
